Thank you for your email.

I have been advised that the following actions were undertaken by the Workplace Health and Safety Queensland (WHSQ) inspectors that attended the Section 47 (3)(b) of the RTI Act

They spoke to Section 47 (3)(b) of the RTI Act who then escorted them around the facility. Section 47 (3)(b) of the RTI Act took the Inspectors to the Section 47 (3)(b) of the RTI Act

Section 47 (3)(b) of the RTI Act The two inspectors examined these Section 47 (3)(b) of the RTI Act and could not identify issues.

A short time later, one of these inspectors, met Section 47 (3)(b) of the RTI Act then took this Inspector to an area on the boundary of the facility. The inspector and Section 47 (3)(b) of the RTI Act had a lengthy discussion about Section 47 (3)(b) of the RTI Act
